

PLANNING CONTEXT

A.1 NSW Planning Framework

A Plan for Growing Sydney

Released in December 2014, *A Plan for Growing Sydney* is the NSW Government's strategy for future of Sydney as both a strong global city and a great place to live while accommodating major population growth.

The Plan will guide land use planning decisions for the next 20 years and presents a clear strategy for accommodating Sydney's future population, and to deliver the housing, jobs and infrastructure to strengthen the global competitiveness of Sydney.

Directions for Greater Sydney

Directions for Greater Sydney was published by the Greater Sydney Commission in 2017 and follows on from *A Plan for Growing Sydney*.

Directions for Greater Sydney provides the foundation for the future planning of Greater Sydney over the next forty years. It identifies Sydney as a global metropolis of three productive, liveable and sustainable cities: the Eastern Harbour City, the Central River City and the Western Parkland City - refer Figure A1.

Directions for Greater Sydney seeks to match the region's growth with strategically planned investments, projects and priorities including in the arenas of land use, transport and infrastructure.

Revised Central City District Plan

Draft District Plans were released in 2016 by the Greater Sydney Commission to complement *Directions for Greater Sydney*. They define the vision, actions and priorities for the five planning districts in metropolitan Sydney.

The *Draft West Central District Plan* covers the Local Government Areas of Blacktown, Cumberland, Parramatta and The Hills, an area expected to experience population growth in the area of about 551,000 people by 2036. It sets out the planning directions and actions required to accommodate this growth while delivering a productive, livable and sustainable city.

Bridging the gap between metropolitan planning and local government planning, the district plan clearly sets out the growth, planning priorities and desired outcomes for the area.

Parramatta Road Urban Transformation Strategy

Released in 2016, Urban Growth developed the Strategy for the Parramatta Road corridor over the next 30 years. It aims to grow and revitalise local communities living and working along the 20km length of the project.

Within the Strategy eight precincts are proposed, one of which is Auburn adjacent to Wyatt Park. The program area extends from Parramatta Road to Boorea Road including an intense employment precinct within the existing industrial area to the north-east of Wyatt Park.

Greater Parramatta and Olympic Park Precinct

The Greater Parramatta and Olympic Park Precinct (GPOP) is an evolving knowledge, health, technology, finance, administration and justice centre. The GPOP will offer better public transport, cultural and sporting facilities and a knowledge intensive, services oriented economy in an area stretching from Strathfield to Westmead, and from Auburn to Telopea, embracing Parramatta and Olympic Park - refer Figure A2.

The area is expected ti be subject to an 85% increase in housing and a 60-70% increase in jobs across four distinct quarters and supported by key infrastructure.

The GPOP is earmarked for rapid transformation, with a total investment of over \$10 billion in the GPOP over the next five years alone.

Carter Street Priority Precinct

In 2013 the NSW Government endorsed the Carter Street Priority Precinct, located within the GPOP (refer Figure A2). The Precinct is expected to accommodate significant jobs and housing growth and the proposal involves rezoning the precinct to develop:

- A high density urban community with potentially over 5,500 dwellings, including a range of housing options from townhouses to apartments in buildings of 4-20 storeys
- Employment uses along the M4 Motorway corridor, within buildings up to 6 storeys
- A mixed use village centre and village square
- A new primary school
- A multi-purpose community facility
- New open space including a 1.8 hectare park at Hill Road, a village park on Uhrig Road, and a new linear foreshore reserve along Haslams Creek south of John Ian Wing Parade.

PLANNING CONTEXT

A.2 Cumberland Council Planning

Auburn Local Environmental Plan 2010

The Auburn Council Local Environmental Plan 2010 (ALEP) remains the relevant environmental planning instrument guiding land use and development surrounding Wyatt Park, until a consolidated Local Environmental Plan (LEP) is developed for Cumberland Council.

The ALEP establishes aims, objectives and principles for the whole LGA, as well as for specific sections or zones of the LGA.

Under the ALEP, Wyatt Park is zoned RE1 Public Recreation. Land use zones applicable to areas surrounding Wyatt Park are shown in Figure A11.

The objectives of the RE1 zone are:

- To enable land to be used for public open space or recreational purposes
- To provide a range of recreational settings and activities and compatible land uses
- To protect and enhance the natural environment for recreational purposes.

No works are permitted within Wyatt Park without development consent. Permissible development within this zone includes child care centres, community facilities, depots, environmental facilities; environmental protection works, function centres, information and education facilities, kiosks, markets, places of public worship, public administration buildings, recreation areas, recreation facilities (indoor), recreation facilities (major), recreation facilities (outdoor), respite day care centres, restaurants or cafes, roads and water recreation structures. Development consent is required for the construction of any of these.

Additional planning overlays for Wyatt Park include s6.1 acid sulfate soils (refer Figure A24) and s6.3 flood planning (refer Figure A25).

Local Centre Upgrades

Informed by state, regional and local strategies and directions, the former Auburn and now Cumberland Council has been planning for increased uplift and development in local town centres to accommodate future growth, including Lidcombe and Auburn.

Draft Auburn and Lidcombe Town Centres Strategy 2016

The Draft Auburn and Lidcombe Town Centres Strategy 2016 was commissioned by Cumberland Council. It builds on the work of the earlier Auburn Town Centres Strategy prepared for the former Auburn Council, as well as other technical studies and the district planning processes by the Greater Sydney Commission.

This strategy has been prepared in recognition that Auburn and Lidcombe Town Centres are at a critical transition point. It identified significant opportunities to improve both the built form and the public domain within the context of increased heights and floor space ratios.

The Strategy proposes a number of principles for the growth of each centre and recommends changes to planning controls to support these principles. The principles build on the strengths of each centre, and enable an improved and more diverse built form, with a greater emphasis on how people interact with each other and with the built environment.

Auburn Town Centre Strategy 2031

The Strategy developed in 2008 provides a vision and direction for planning, community, transport, economic and environmental issues to guide strategic planning policies over the next 25 years.

Key themes and actions of the Strategy include:

- The Auburn town centre will be compact and well-defined with improved development quality and viability. Building height controls are reconsidered to ensure consistency with other built form controls so that development potential is not constrained to a greater extent than intended
- Access to and circulation within the Auburn town centre will be integrated, safe and convenient, with priority for walking, cycling and public transport
- A significant public space at the Civic Road, Queen Street and Auburn Road intersection on the western corner of Queen Street and Auburn Road and on the northeastern corner of Civic Road and Auburn Road.

Auburn Residential Development Strategy 2015

The Auburn Residential Development Strategy outlines a 20 year strategy to guide the planning for future housing needs in Auburn City. The Strategy indicates a number of developable sites within a kilometre of Auburn Station and Lidcombe Stations for multi-level (up to 19 storeys) buildings. These would accommodate residents in high-density which will increase the demand of open space available to these residents.




Figure A1: The Three Cities Model showing location of Wyatt Park




Figure A2: Parramatta Road Urban Transformation Area showing location of Wyatt Park

Planning Context - Key Findings

- Wyatt Park is located in the 'Central City' as per the 3 city model developed by the Greater Sydney Commission.
- Wyatt Park is located in relative proximity to the 'Eastern City' and easily accessed by car.
- Wyatt Park is located in close proximity to major growth areas and centres, both within the Cumberland LGA and in surrounding areas including
 - The GPOP
 - The 'New Parramatta Road' urban renewal corridor
 - Lidcombe and Auburn Town Centres.

Implications and Opportunities for Wyatt Park

- There is pressure from clubs and groups outside the LGA to use the park, spilling over from other areas as open space and recreation facilities in the 'Eastern City' are at/ beyond capacity
- Population growth will result in increased pressure at the local/ district level for access to open space including
 - Competition by various sporting clubs and codes
 - Increased demand from unit dwellers for access to informal open space.

DEMOGRAPHICS

A.3 Demographic profile

Key Findings

- A young population the largest and fastest growing group are young adults 20-34 year olds (31% compared to 22% across Sydney)
- Culturally diverse highly represented cultures include Lebanese, Chinese, Indian, Afghani, Nepalese and Turkish
- Low income: 2nd most disadvantaged LGA with a median income at 78% of the Greater Sydney average
- A transient population
- High portion of renters
- High portion of families (54.5% compared to 49.5 in Sydney)
- Higher unemployment levels
- · Greater share of high density living
- By 2036 dwellings are expected to increase
 - 60% in the Auburn area
 - 81% in the Lidcombe area
- By 2036 the population of Cumberland is expected to grow by an additional 75,000 people

Implications and Opportunities

- There is growing demand for sport and recreation facilities
- There is a need to provide for access to open space as the area densifies and private open space diminishes.
- There is a need for low-cost/ free facilities
- There is demand for community development activities such as festivals and cultural celebrations
- There is a need for culturally appropriate facilities and a range of sports and recreation options that appeal to the culturally dominant groups, i.e. soccer, football, basketball, volleyball and badminton, squash, table tennis, futsal, (social) cricket, wrestling and combat sports






Figure A7: Dominant dwelling structure 2007 (source: Former Auburn Development Contributions Plan 2007 Amendment-2-2016)

A.4 Open Space

Key Findings

- The park is one of the major sports parks in terms of size in the eastern Cumberland LGA.
- The park represents a major sporting precinct. The nearest playing fields include
 - Mona Park (1.8km distance; 4 fields)
 - Webbs Avenue Playing Fields (1.9km distance; 4 fields)
 - Phillips Park (1.4km; 3 fields)
 - Auburn Park (1.1km; one field).
- Sydney Olympic Park is nearby and provides a major regional/ national sporting and recreation destination.
- There is limited open space in Lidcombe and Auburn.
- Much of the available open space in Lidcombe and Auburn is either very small or dedicated to sports uses.
- Rookwood Cemetery, while not open space, is a large area that can accommodate some of the demand for passive recreation and access to nature.

- Wyatt Park needs to remain a major and district sporting destination if future needs are to be met.
- Major and regional sporting needs are met by Olympic Park.
- Many parks have a sports focus or are small or undeveloped, resulting in a limited recreation offering. There is unmet demand for general open space for social and family recreation (SFR) across the LGA.




Figure A8: Location of Wyatt Park relative to the Cumberland LGA






Figure A9: Open space near Wyatt Park

A.5 Existing parks and schools within Cumberland Council

Parks

With the exception of Sydney Olympic Park, Wyatt Park offers the largest range of sporting facilities within Cumberland Council (Table 6). Sydney Park is approximately 4km away (8 minute drive) with a proposed open space area to the east to accommodate indoor golf, rugby, crickets, baseball, futsal. There are a number of other sports grounds within Cumberland Council, with Auburn Park and Phillip Park being the closest at 500 and 900m respectively (Figure J).


There are a few parks nearby to Wyatt Park with play equipment, however the *Auburn Open Space and Recreation Contributions Study* (Cumberland City Council, 2017) identified an opportunity for play spaces to service the residential areas to the north-east of Wyatt Park. There are no district parks within a 5km radius of Wyatt Park.

Schools

There are six education facilities within 1km of Wyatt Park, one with full size sporting facilities including indoor and outdoor courts. This is AL-Faisal College which is a non-government, Islamic, combined primary and secondary school. The majority of schools within a 3km radius of Wyatt Park don't have full sized sporting courts and fields.

A.6 Land Use Zoning

Key Findings

- •The park is surrounded by a mix of industrial and residential uses.
- • The park is in close proximity to the Auburn and Lidcombe Town Centres and their respective railway stations.
- • The park is surrounded on three sites by major road and rail infrastructure, i.e. Olympic Drive and the Western Rail Line.
- • The park is zoned RE1 Public Recreation, objectives are to
 - Enable use for public open space or recreational purposesProvide a range of recreational settings and
 - activities and compatible land uses
 - Protect and enhance the natural environment for recreational purposes.
 - Protect open space at riparian and foreshore locations.
- Wyatt Park is the most significant open space provision by far.

- The park is cut off from residential areas by road and rail.
- The park is within walking and cycling distance from the town centres and rail stations.
- The park has the potential to meet the needs of the local residential community for both sport and general recreation.
- There is an opportunity to enhance links to nearby open spaces and community facilities including schools and town centres.
- There is an opportunity to investigate a future pedestrian bridge connecting Milton Street to Wyatt Park.




Figure A11: Land use zoning of areas surrounding Wyatt Park

A.7 Vehicular Access

Key Findings

- • There is only one formal access point at Church Street.
- • Gated vehicle entrances are located at Percy Street and Boorea Street and are available for events and emergency vehicles.
- A number of roll-over kerbs along Olympic Drive provide informal/ casual access, but is not supported by RMS.
- An internal road links
 - Church Street and Percy Street and provides access to the basketball centre
 - Church and Boorea Street and provides a traffic route for managing major events.
- The RMS in 2008 provided in-principle support for a signalised four-way intersection opposite Boorea Street.
- Public parking is provided both off-road and on-road at Church Street (~490) and Percy Street. Overall capacity is ~640 spaces.
- The PCYC and the basketball centre have small car parks associated them.
- Overflow parking is available on gravel areas around the basketball centre, on Wyatt Park fields and along Olympic Drive

- Given the size of the park, it would benefit from more than vehicle entrance to avoid congestion and provide activation.
- Areas along Olympic Drive could be serviced by an additional or upgraded bridge crossing over Haslams Creek.
- Consider consolidating car parking, to optimise layouts and share car parks between different venues/ facilities, in order to free up the park for other uses.



A.8 Active Transport Access

Key Findings

- There are limited paths within or around the park, making it difficult to get to or walk/ cycle around in the park.
- Driveways/ internal access roads can be shared by pedestrians but there's no formal demarcation.
- Olympic Drive can only be crossed at Boorea Street and Church Street, making it hard to get to the park. Crossings are of low pedestrian amenity and offer a poor arrival experience.
- Church Street provides a cycle link between Lidcombe and Auburn, with shared road use along Church Street.

- Improving active transport connection has the potential to make the park more attractive as a youth space/ destination.
- Enhance the park as a walk-to destination through more direct, convenient and pleasant pedestrian access.
- There's an opportunity to improve pedestrian and cycle links
 To/ from the town centres/ rail stations
 - To/ between existing venues and facilities.
- There is an opportunity to enhance the park as a destination for the purposes of recreational/ fitness walking/ cycling themselves.
- Make the park more accessible including to a wider audience (the elderly, disabled, people with strollers etc) through the provision of safe, attractive and well-located paths.
- There's a need for ancillary infrastructure such as bike racks, lighting and way-finding/ signage.





A.9 Existing Facilities Type and Utilisation

Key Findings

- Wyatt Park is primarily developed for sporting use with a number of facilities catering for formal/ organised sporting use through clubs and other organisations.
- There are a number of high quality facilities.
- Many facilities currently operate below capacity with the exception of Lidcombe Oval during the winter season, and the basketball centre.
- There is a large number of small buildings dispersed through the park, adapted from other uses. Yet, there is inadequate storage.

- Take advantage of high quality facilities to continue to provide a sporting destination.
- Ensure facilities meet local need by attracting/ engaging the local community.
- Increase use including casual (non-club/ membership based) use and non-sporting use, including through greater shared use.



A.10 Existing Facilities Condition and Investment

Key Findings

- There is a contrast between high quality facilities and facilities that are deteriorating and/ or in poor condition.
- Recent investments towards meeting community needs include upgrades of the pool, netball court and velodrome.
- A number of facilities are aged and/ or do not comply with current building codes and regulations.
- The skate bowl, dog park and former tennis centre are unsafe, not fit for purpose or defunct.
- There is no dedicated storage area or compound for greenkeeping/ maintenance materials and equipment.
- Council has committed to assist the CBC with the expansion of the centre to provide for an additional court.

- Improve the presentation of buildings in the park to make them more attractive.
- Maintenance/ upgrading of facilities represents a significant backlog of work, as well as capital commitment.
- Capital costs associated with building upgrades may exceed the cost of purpose-built structures.
- Consider purpose-built facilities to better meet user needs, as well as current codes and building standards.
- Consider renewing facilities and provide flexible facilities and buildings for shared use, in order to
 - Maximise building utilisation
 - Provide a sense of continuous activation around a central facility
 - Reduce the maintenance burden associated with a large number of small buildings.
- Removal of redundant/ defunct or poorly adapted structures represents an opportunity to de-clutter the park to make space for additional activities, and maximise views and passive surveillance.

A.11 Existing Use Agreements (Leases and licences)

Key Findings

- Large sections of the park are controlled by organisations other than Council, through leases and licences.
- Indoor facilities and some parts of the park can only be enjoyed by club/ organisation members, for a fee.
- There are concerns about the degree to which management by other organisations is aligned with Council's interest in providing for local community and sporting needs.
- Rents/ annual fees are generally well below market value.
- There is concern that sub-letting/ hiring out of facilities is creating income and/ or profit for clubs at Council's expense.
- Clubs manage facilities according to their own criteria and do not necessarily consider outcomes for the park/ the local community as a whole.
- There is little coordination amongst clubs about what's on offer.
- A number of uses have a poor relationship with the park, i.e. they don't take advantage or use the park setting.
- Council is currently in negotiations with Parramatta Basketball Association (current lease expires 1 January 2022).

- The Scouts' arrangement remains unresolved.
- Council is subsidising club use.
- Some uses are not site-specific and may be able to be re-located to free up park land for other uses.
- There is an opportunity to develop usage agreements to realise greater alignment with Council objectives of catering for locals, and to prevent revenue being channelled to other parties through sub-letting/ hiring out of park facilities.

A.12 Fencing and Public Areas

Key Findings

- There are a large number of fences around individual facilities.
- Fencing protects valuable assets against vandalism/ damage/ inappropriate use.
- · Fencing visually and physically divides the park
- Large sections of the park are not accessible by the general public (for free).
- Parts of the park publicly accessible and fee-free tend to be poorly embellished or undeveloped, i.e. "left-over".

- Fencing provides an opportunity to set up the park as a venue for ticketed events.
- Review fence types and locations:
 - Consider alternative means for preventing vehicular access to valuable fields while allowing greater general community use.
 - Review fence alignments to maximise space outside of fences facilities for general community use and enable free movement and views through the park.
- There is a need to enhance publicly accessible spaces to provide general recreation facilities that are safe, attractive and free and invite use of the park by the general community.





A.13 Undeveloped Areas

Key Findings

- There are significant portions of land that have no designated use and remain undeveloped.
- There are "left-over" areas of land around the venues that have no current useful purpose.

- There is sufficient land area to accommodate additional uses in the park.
- There's potential to complement existing facilities with additional park/ recreation infrastructure to maximise the park's potential as a whole of family destination, such as play or exercise equipment close to sports fields.
- Means to maximise space for other uses include:
 - Reconfiguring existing facilities
 - Reconfiguring fences around facilities
 - Strategically relocating facilities to create larger contiguous areas for uses not currently represented in the precinct.



A.14 Existing Facilities - Target User Groups

Key Findings

- Similar functions are dispersed throughout the park, i.e. youth facilities and services.
- Some functions are duplicated, potentially at the expenses of offering a more diverse range of activities i.e. basketball.
- Many facilities target young people and young adults which is consistent with the demographics of the area.
- There are no playgrounds or other publicly accessible (free) facilities specifically for toddlers/ preschoolers and primary-aged children.
- There is a bias in provision towards the needs of young males.
- There are no facilities specifically for the elderly.
- Most activities require membership or payment, limiting participation in an economically disadvantaged area.

- Provide a broader range of activities in the park to appeal and cater to the needs of a wider range of demographic groups, including those not currently catered for.
- Consolidate youth facilities to create a vibrant youth precinct.
 - Co-location of youth facilities and services may offer synergistic benefits for individual organisations.
 - The current Planning Proposal for a new school in Percy Street has the potential to contribute to park activation and a vibrant youth precinct.
- Setting up the park as a place for free outdoor activities is a major opportunity to activate the park and meet the needs of an economically disadvantaged community.

A.15 Existing Facilities - Planned Improvements

Key Findings

- Council has committed to a series of improvements:
 - Basketball Centre asbestos roof replacement and extension/ additional court (late 2017)
 - Re-surfacing of the bottom 6 netball courts (late 2017/ early 2018)
- Council has committed to demolishing
 - Disused advertising sign at the corner of Percy Street and Olympic Drive
 - The former Lidcombe Tennis Centre demolition has commenced
- · Council has previously approved removal for
 - Wyatt Park amenities block
 - Lidcombe Oval kiosk

(Timing is subject to the provision to new amenities proposed in this PoM)

Implications and Opportunities

• Investment in improvements may limit masterplanning/ opportunities for structural changes in the short or medium term.

A.16 Passive Surveillance

Key Findings

- The vast majority of the park enjoys only limited passive surveillance or casual overlooking from either buildings or roads/ passing traffic.
- Visibility of the park from the rail line has a limited effect on deterring crime or anti-social behaviour.

Implications and Opportunities

- The park would benefit from increased passive surveillance for
 - both actual and perceived safety/ security. Means might include:
 - Provide additional vehicle access/ parking points to draw people into all sections of the park.
 - Provide vehicle access through the park for greater casual surveillance.
 - Provide facilities/ services with all-day use/ operation to have a presence in the park at all times.
 - Increase building fenestration/ transparency for improve indoor-outdoor relationships including greater casual over-looking of adjoining park spaces.
 - Improved linkages through the park this could be for all modes: pedestrians, cycling, cars.
 - Strategic approach to landform and vegetation to provide/ maintain clear sight lines.
 - Technology including CCTV.
 - Law enforcement including regular police patrols.
 - Lighting to improve night-time safety/ security.
 - Formal external programs or led/ supervised activities.

A.17 Views and Shade

Key Findings

- Existing trees provide an attractive visual backdrop to many of the venues in the park.
- The park provides a green counterpoint to urban areas.
- There's a series of visually contained separate spaces within the park.
- There are limited landmarks visible beyond the park to provide a sense of orientation. They include
 - The Gallipolli Mosque
 - Lidcombe Towers
 - A number of industrial buildings
 - A number of high-rise buildings in the town centres
- The skyline surrounding the park is expected to change and develop with urban renewal and increased densities.
- There is limited shade around key venues.

Implications and Opportunities

- Assist orientation through improved circulation systems and signage.
- Enhance the sense of place by framing/ strengthening views to other community places such as the Gallipolli Mosque.
- There is a need for more shade for greater visitor and spectator amenity.
- Build on the existing series of distinct spaces to create a sequence of distinct park/ character areas, separated by treed areas to provide shade and an attractive backdrop.
- The park will make a visual contribution to the amenity of future apartment-dwellers over-looking the park.
- The park has the opportunity to be enhanced to provide an 'oasis' for relief from urban areas.



Implications and Opportunities

- The site is likely to be contaminated based on past uses, with potential implications for redevelopment costs.
- The park is locally significant due to:
 - The park has a continuous history as an important sportsground.
 - The park has a long history and association with a number of clubs/ user groups.
 - The park has continually evolved over time to meet and accommodate changing needs and demands.
 - Evidence of past history and uses survives in some of the park's buildings and structures.
 - The park has an important association with social events and services including depression relief works and youth services.

A.19 Heritage Items and Significant Trees

Key Findings

- The ALEP lists as local heritage items:
 - Wyatt Park, with special mention of the Ruth Everuss Aquatic Centre, Wyatt Park Youth Centre, Lidcombe Oval and Grandstand and Haslams Creek
 - A line of Tallowoods (Eucalyptus microcorys) along Olympic Drive
- Significant trees include
 - The heritage-listed Tallowood trees
 - A number of Tallowood trees (E.
 - microcorys) throughout the park
 - One Lemon-scented gum (Corymbia citriodora)
- The Draft Wyatt Park Heritage Study recommends
 - A number of further items for heritage listing
 - Partial elevation to state significance
- Additional trees near the Ruth Everuss Aquatic Centre be listed as significant, namely:
 - One Hill's Weeping Fig (Ficus microcarpa var. Hillii)
 - Two Cottonwoods (Populus deltoides)

Implications and Opportunities

- There is a need for clarity around the precedence of heritage values i.e. social heritage values relative to built fabric.
- There is a need to resolve to what extent fabric can be altered or removed.
- Build on existing mature and significant trees to further enhance the landscape character and restore or reinstate native and riparian ecology.
- Parts of the park could contribute to the local "urban forest" of future significant tree cover and to counter urban heat island effects.



A.20 Landform and Hydrology

Key Findings

- The park is generally flat with some mounding around the stormwater harvesting tank and Lidcombe Oval.
- Mounding contributes to visual separation of various parts of the park and visually isolates the dog park
- The park drains towards the Haslams Creek channel.
- Areas within the Park that are high-risk to flooding are located along the canal an the northern end of the Park near Boorea Street. Medium risk flood areas extend from the canal and expand in the southern and northern ends. Low-risk flood areas largely cover the sports fields and netball courts. The three categories of flood risk are defined below.
 - High flood risk
 - The area within the envelope of land subject to a high hydraulic hazard (in accordance with the provisional criteria outlined in the Floodplain Management Manual) in a 100 year flood or potentially subject to evacuation difficulties.
 - Medium flood risk

Land below the 100 year flood level (plus freeboard) subject to low hydraulic hazard (in accordance with the provisional criteria outlined by the Floodplain Management Manual).

- Low flood risk

Land within the floodplain (i.e. within the extent of the probable maximum flood) but not identified as either a high flood risk or medium flood risk, where risk of damages are low for most land uses.

- Development consent is required under the 'Flood Planning clause of the ALEP.
- Flooding has potential to cut off access to the park.
- Previous studies have suggested that a flood detention basin in Wyatt Park may be a means to facilitate greater development of the catchment including uplift in the town centres.
- Much of the park is affected by acid sulfate soils (class
 - 2). Development consent is required for work
 - Below the natural ground surface
 - By which the water table is likely to be lowered.
- Development requires the preparation of an acid sulfate soils management plan as per the *Acid Sulfate Soils Manual*.


Implications and Opportunities

- Flood risks zones have implications for development within the park as they indicate areas of risk to life and property. Buildings within low and medium flood risk areas are permitted providing they adhere to the controls set out in the DCP.
- The park would benefit from an additional entrance/ flood evacuation route.
- Development proposals needs to be assessed against a number of constraints.

A.21 Utility Infrastructure and Easements

Key Findings

- The major utility infrastructure element is the Haslams Creek stormwater canal.
- A full survey of utilities is not available. All facilities have access to power and water/ sewer and there is an overhead power supply along Church Street.
- A 'Dial Before You Dig' search revealed there is
 - A sewer main parallel to Haslams Creek
 - A sewer line to the basketball centre
 - A water main along Church Street and to the basketball centre.
- Information on the power supply was not available (2 or 3 phase?). Anecdotal evidence indicates generators are required for events.
- There are no major utility easements crossing the park.
- Limited utilities or connection points are available.

Implications and Opportunities

- Utilities do not appear to interfere with existing spaces and facilities.
- The lack of connection points increases the cost of utilities and staging events.

Identified Opportunities

- Future open space needs will be met through sustainable management and park improvements.
- There is a need to resolve whether and where synthetic surfaces should be provided at Wyatt Park, to provide for increased capacity.
- There is a need for innovative, flexible and multipurpose recreation facilities.
- There is a need to clarify the need/ desire for a multisports facility at Lidcombe Oval.
- There is a need for a good distribution of social/ family recreation spaces that cater for people of all ages and abilities.
- At least \$7.5M has previously been allocated for Wyatt Park improvements but not yet been spent. Funds should be available for improvements.
- Schools are often under-provided with fields/ open space. Wyatt Park is an ideal location for shared community/ schools use, in particular in light of the proposed school at Percy Street.
- There are a series of safety issues and concerns in Wyatt Park, including around the Youth Centre: safety/ CPTED needs to be considered.
- There is a need to provide facilities conducive to participation by females and locally prevalent cultural groups.
- Wyatt Park offers the potential to provide for access to enhanced natural areas.
- Many recreation facilities and opportunities under-catered for across the LGA could be accommodated in Wyatt Park including
 - Climbing walls
 - Community gardens
 - AFL
 - (Social) cricket
 - Soccer
 - "Free to play" tennis courts with lights
 - Free full-size basketball courts
 - Social-family recreation areas
 - 'Pay and play' sport outside of clubs
- A local and a district playground should be provided in Wyatt Park.

RELEVANT DOCUMENTS

- There are a number of gaps in youth provision that could be met by Wyatt Park including
 - A central, accessible information 'hub' to get information and seek help
 - A facility that can accommodate large numbers of people (i.e. 1,200+ people) for events
 - Multi-purpose rooms i.e. music, movies

 - Girls only spaces for use by girls and young women (and associated programs)
 - BBQ areas
 - Skate parks/ BMX facility

 - Indoor sport and recreational facilities and gyms
 - Cafes and food outlets
- Other recommendations
 - Cover the drainage channel

 - Community focussed fitness centre including free running/ a running club
 - New amenities at Lidcombe Oval
 - Short term parking/ drop-off zones
- There is demand, and therefore significant opportunity, to activate the park through a

B.1 Consultation Overview

The following provides an overview of the consultation process and key outcomes. The consultation process is described in more detail in the *Wyatt Park Plan of Management Consultation Outcomes Report* in the following section of this Appendix.

Consultation Purpose

- The consultation process aimed to provide the opportunity for key stakeholders and the broader community to provide information and their perspectives on the existing park and ideas for the future
- The information received will support the development of the Plan of Management.

Consultation Activities

Interviews

Interviews with Council officers from Community and Culture, Properties and Facilities, Recreational Parks to discuss

- Council's roles and responsibilities at Wyatt Park
- · Existing use, agreements and arrangements
- Park functionality and condition and improvements required

Interviews with 14 organisations using the park. Interviews focused on:

- How the organisation and its members currently use the park
- What is working well and what is not working well
- · Improvements and changes required to facilities and the park
- Ideas for the park in the future

Community Survey

Online and hardcopy community survey (144 responses).

Designed to be relevant to diverse types of park users including:

- Representatives of sporting groups and community organisations
- Clients/members/participants in these groups and organisations
- The broader community

It was also designed to be relevant to non-users of the park.

Questions asked related to:

- How people currently use the park
- · What is working well and what is not working well
- The role of the park in the future

- Interests and preferences in relation to activities, services, programs and events
- The types of spaces, facilities, amenities and other inclusions that should be provided

B.2 Key findings from consultation

Key Messages from Council Officers

- Consider the role of Wyatt Park in Cumberland LGA's open space network
- Leasing, licensing and maintenance agreements generally working well
- Assessment of facilities is to be completed but there is likely to be a significant amount of work required
- Park well-suited to large scale events but supportive infrastructure is required
- Increasing park amenities and utilisation will increase maintenance works and resources required
- Focus on community needs when determining services, programs and activities provided at the park (ability of an organisation to contribute financially should be considered a bonus)

Key Messages from Existing Park Organisations

- Overall support for increased use (increased membership as well broader community use)
- Improved clarity around use agreements required
- Overall support for improved communication and increased co-ordination between park organisations
- Poor signage and wayfinding
- · Poor visual and physical access (to and around the park)
- · Need to improve overall park aesthetic and condition of facilities
- Need to improve lighting and amenities at facilities and around the park (toilets, change rooms, clubhouses, water stations, seating, shade and shelter)
- Parking is generally good but condition needs to be improved and peak demand managed

- Increase participation in existing activities/ venues (many are operating below capacity)
- Greater coordination/ cooperation amongst stakeholders including organisations and council
- Increased utilisation of some facilities (many are operating below capacity)
- Increased offering of activities, programs, events and services to attract people to the park and better meet community interests and needs
- Consideration of greater resources required to maintain an upgraded park with increased utilisation
- Resolution of ambiguities regarding maintenance and repairs in use agreements to achieve a better cared for and more inviting place.

Executive summary

Cumberland Council is developing a Plan of Management for Wyatt Park (the park). The Plan of Management will respect the existing values of the park and outline strategies for the park's future use. When completed, it will assist Council in planning, prioritising and financing the future works and management of Wyatt Park.

Wyatt Park is positioned between Auburn and Lidcombe town centres and includes many sport and recreation spaces and facilities. The park is currently utilised by a range of organisations through a variety of use agreements with Council.

The development of a Plan of Management for Wyatt Park has been supported by an extensive consultation process which has engaged Council officers, organisations located at the park's facilities and spaces, as well as the broader community. Methods of engagement have included:

- » Phone interviews with Cumberland Council officers (from Community and Culture, Properties and Facilities and Recreational Parks departments) who have various levels and types of involvement with Wyatt Park
- » Interviews with representatives from organisations utilising the park's spaces and facilities, examining their current use and feedback on aspects of the park used by the organisation and their members
- » A community survey, hosted on Council's website and provided at facilities in the park and Council service centres, aimed at gauging broader community feedback on the current use, necessary improvements and future visions for Wyatt Park.

A summary of findings from each of the above consultation methods is provided in the following chapter sections:

- » Section 3.5: Summary of key findings from consultation with Council officers
- » Section 4.11: Summary of key findings from consultation with park organisations
- » **Section 5.3:** Summary of key findings from consultation with the broader community

Needs for Wyatt Park based on feedback

When responses from Council officers, organisations and the wider community are combined, the suggested needs for Wyatt Park can be considered in two categories:

- » Physical changes or improvements to Wyatt Park, which could be addressed in the Masterplan
- » Existing licensing, leasing, management and programming arrangements, which could be addressed at an organisational level.

Physical changes or improvements required:

- » Improved access and parking
- » Improved safety (lighting and surveillance)
- » Improved pedestrian circulation around the site and connections between facilities and spaces
- » Improved signage/way-finding
- » Improved amenities at facilities (including change rooms, toilets, canteens, storage, shade, shelter seating and water stations)

- » Improved amenities across the park (including shade, shelter, public toilets, park furniture, bins and bubblers)
- » Improved building quality and appearance
- » Provision of spaces and amenities that support informal recreation (including BBQs, picnic areas, playgrounds and a continuous cycle and walking path around the park)
- » Better support of events at the park, through better access to utilities and amenities (water, power, shelter etc).

Operation and management improvements/changes required:

- » Greater promotion of what is on offer (increasing promotion/awareness of what is available) by Council and park organisations
- » Greater coordination/cooperation amongst organisations at the park, facilitated or supported by Council
- » Increased utilisation of some facilities (many are operating below capacity)
- » Increased offering of activities, programs and services provided, and the hours during which they are provided
- » Resolution of ambiguities related to maintenance responsibilities in use agreements
- » Consider and plan for an increase in maintenance resources if additional amenities are provided and there is increased utilisation of the park in the future.

1 Introduction

This report provides an outline of the consultation process undertaken to inform the development of a Plan of Management for Wyatt Park Lidcombe, undertaken on behalf of Cumberland Council.

1.1 Project overview

Cumberland Council has committed to developing a Plan of Management for Wyatt Park. The Plan of Management will respect the park's existing recreation, heritage and ecological values, while also outlining clear, measurable and achievable strategies for its future use. The Plan of Management will also integrate a landscape concept plan, visually representing potential future uses and facilities at the park. When completed, the Plan of Management will become a working document which will assist Council in the planning, prioritisation and financing of future works and management of Wyatt Park.

1.2 About Wyatt Park

Wyatt Park is located between Lidcombe and Auburn town centres. The park is bounded by Olympic Drive, Church Street and Percy Street. Wyatt Park currently includes a number of sports and recreation facilities and spaces, outlined in the following table. Many of these spaces are used by community organisations and groups (through various use arrangements with Council).

2 Consultation overview

2.1 Consultation objectives

The consultation process involved a series of activities which engaged relevant Council officers, key organisations (organisations accommodated at or using park spaces and facilities) and the broader community.

The process aimed to provide the opportunity for different organisations and the broader community to provide information on their use and their perspectives on the existing park and ideas for the future.

The information received in the consultation process will support the development of a Plan of Management and associated landscape concept plan which reflects the needs and interests of the Cumberland community.

2.2 Consultation activities

A consultation plan was developed to guide the consultation process. The consultation plan identified key organisations and outlined the consultation activities to be conducted. The plan was provided to and approved by Cumberland Council prior to commencement of consultation.

The following consultation activities were undertaken as part of the study.

Interviews with Council officers

Three separate phone interviews were conducted with Cumberland Council officers from various service areas involved in the operations and management of Wyatt Park. This included Community and Culture, Properties and Facilities and Recreational Parks.

The interviews sought to gain information on:

- » Council's roles and responsibilities at Wyatt Park
- » Existing use, agreements and arrangements between organisations using the park and Council
- » Functionality and condition of park spaces and facilities and improvements required.

The interviews also examined ideas for how the park could best meet community and Council's needs in the future.

Interviews with park organisations

Individual face-to-face and phone interviews were conducted with representatives of the organisations currently accommodated at facilities within Wyatt Park, listed in Table 1, section 1.2, with the exception of Auburn Warriors Rugby League Club (representatives of the club chose not to participate in an interview).

When possible, interviews with representatives from the various organisations where conducted at Wyatt Park, within the area or facility used by the organisation.

Each interview examined:

- » How the organisation and its members currently use park facilities
- » What is working well and what is not working well in relation to the facilities used by the organisation, as well as the park as a whole
- » Improvements and changes required to facilities and the park to better meet needs (of the organisation, its members/participants and the broader community)
- » Ideas for the park in the future.

Themes from Council officer and key organisation consultations

In the interviews, there were commonalities in the discussions and experiences described by Council officers and organisations interviewed. The themes are used throughout this report and include:

Location:	Wyatt Park's location within the Cumberland LGA, in relation to Auburn and Lidcombe train stations and other park spaces	
Size:	The park size compared to other Cumberland LGA park spaces	
Accessibility:	Pedestrian and cyclist accessibility to and within Wyatt Park	
Aesthetic:	The visual appeal of the grounds and buildings in Wyatt Park, looking both outside and within the park	
Utilisation:	The types of activities taking place at Wyatt park, and how often they are being use by the Cumberland community	
Agreements:	Agreements in place between organisations at Wyatt Park and Council regarding maintenance, reporting and leases. This theme also aligns with communication and reporting changes following the recent Council amalgamation	
Parking:	The availability of parking for Wyatt Park users	
Amenities:	The presence and condition of amenities for public use in Wyatt Park, including toilets, seating and tables, shade, drinking facilities, play equipment and access to taps and electricity

While themes were covered across the combination of interviews, not every theme was discussed in each interview by each participant.

Community consultation

Community survey

A community survey was developed and administered to gain feedback and input from the broader community. The survey was provided in an online format (hosted on a webpage on Council's website). A hardcopy survey was also produced and provided at Wyatt Park facilities and Council's administration facilities. The survey was open/available from 31 May to 23 June 2017.

Both the hardcopy survey and a printable version of the online survey is provided in Appendices A and B.

Survey promotion

Promotion of the survey included:

- » Emails to key organisations and other relevant contacts in Council's database. The email promoted the survey and contained an electronic link to the survey. The email also encouraged recipients to forward the email/survey to their members and other contacts
- » Advertisement in a local newspaper
- » A webpage on Council's website
- » Hardcopy surveys provided at park facilities
- » Promotion on Council's Facebook page.

Language services

Phone-based language assistance services were also provided by Council to assist people from different language groups to complete the survey. These services were offered in Dari, Turkish, Arabic, Chinese and Korean. The services were advertised in these languages on the survey webpage and the introductory section of the hardcopy survey.

Survey focus and scope

The survey was designed to be relevant to diverse types of park users including representatives of sporting groups and community organisations, clients/members/participants in these groups and organisations as well as the broader community. It was also designed to be relevant to non-users of the park.

The survey aimed to gain information, feedback and ideas from the community in relation to:

- » How people currently use the park (how people get there, when they use the park and what they do there) and, if people do not use the park, why they do not use it
- » What is working well and what is not working well in relation to the park overall as well as individual spaces and facilities
- » Preferences in relation to the role of the park in the future
- » Interests and preferences in relation to activities, services, programs and events to be provided at the park in the future
- The types of spaces, facilities, amenities and other inclusions that people would like to see provided at the park in the future.

A question asking respondents whether they were interested in keeping up-to-date on the progress of the Plan of Management was also included. 59 respondents were interested and provided contact details.

The hardcopy version was a shorter survey that focused on the park in the future (preferences in relation to the role of the park and activities, services, programs, events, spaces, facilities and amenities to be provided).

3 Outcomes of consultation with Council officers

This chapter provides a summary of the outcomes of the interviews conducted with Council officers. Cumberland Council identified the following Council officers to be interviewed during the consultation process:

- » Group Manager, Community and Culture
- » Acting Group Manager, Properties and Facilities
- » Supervisor, Recreational Parks.

The interviews were individualised for each participant, allowing them to discuss experiences and visions for Wyatt Park related to their fields of expertise. This provided a range of perspectives around existing use, maintenance and functionality of Wyatt Park.

The following three sections outline the outcomes by interview, with a fourth section providing a collation of ideas from Council officers for Wyatt Park in the future.

3.1 Communities and Culture

Interview with Group Manager, Community and Culture

This interview explored wider community use of Wyatt Park and discussions around the existing organisations using the park.

Community use

The park is best utilised for large scale community events (as opposed to small local events), as the position and size means that:

- » Events can be held with minimal disturbances to residents
- » Parking can be provided on-site
- » Traffic management is complimented by the existing road system.

However, an absence of necessary amenities in Wyatt Park has an impact on the park's functionality and appeal to community organisations for hosting larger events. This includes:

- » No access to electricity, requiring organisations to hire generators
- » Difficult and limited access to water outlets
- » No shaded areas, requiring organisations to provide their own canopies for protection.

Additional barriers to greater community use include poor access into the park (lack of pathways), an uninviting feel, the lack of promotion of park activities in the wider community and the poor condition and aesthetic of facilities, such as the Auburn Youth Centre building frontage.

Enhanced communication and coordination between organisations at the park could help to increase utilisation of the park. There is also the need for greater promotion of park offerings to the wider community to increase awareness.

3.2 Buildings and facilities

Interview with Acting Group Manager, Properties and Facilities

Cumberland Council's Properties and Facilities section are responsible for building maintenance, annual building auditing and leasing/licencing agreements for buildings at Wyatt Park.

Building maintenance

Existing buildings in Wyatt Park (excluding the Ruth Everuss Aquatic Centre) required upgrade and maintenance works.

Recent Council amalgamation had impacted on the previous asset management/repair prioritisation list. Detail on the work required cannot be provided until completion of the assessment of assets (currently being undertaken). Although the findings are not available it is known there is a back-log of work required to upgrade facilities at Wyatt Park.



Asset management across the three merged councils varied. We are now aligning these and developing a Strategic Management Plan. For the next three to four years we will be working on bringing all facilities up to a reasonable level (there is some backlog we need to do before moving onto additional works).

Annual auditing

Properties and Facilities conduct an annual audit on each facility, ensuring it is being maintained to required standards. Previously Property and Facilities were under-resourced and this had affected the audit process, resulting in buildings at Wyatt Park not being maintained to the required standard.

Leasing and licensing

There are various arrangements for the different facilities including:

- » Council undertaking building maintenance for facilities under license agreements
- » Organisations funding and performing their own building maintenance, keeping Council informed
- » Organisations providing the funds and Council undertaking the work
- » Organisations maintaining the building and Council contributing to upgrades.

Reporting arrangements between organisations and the necessary Council personnel continues to be effective post-amalgamation.

A feedback summary from the interview is organised by theme in the following table.

3.3 Grounds maintenance

Interview with Recreational Parks Supervisor

The Recreational Parks Supervisor is responsible for overseeing the maintenance of grounds and sporting fields in Wyatt Park.

Maintenance of grounds and sporting fields

There are two Council staff who undertake all grounds maintenance at Wyatt Park, five full days a week. This work covers the entirety of the park (excluding Ruth Everuss Aquatic Centre) and involves:

- » Mowing and marking sporting fields
- » Pest eradication
- » Watering and irrigation maintenance
- » Reporting of damage or graffiti to appropriate Council contact.

Organisation use and maintenance

Arrangements between organisations and Council regarding grounds maintenance have worked well in the past because:

» Organisations know who to contact to report maintenance issues

» Organisations are familiar and understand the arrangements around maintenance and specific park area use

Post-amalgamation, however, there have been some confusion regarding the appropriate Council contact.

With regard to facilities requiring significant time and resources –the Atheltics Track is particularly time consuming. It involves marking the lines once a week or once a fortnight, depending on its use. Considering maintenance models employed by other Councils, this work could be done by the organisation using the grounds, freeing up one full day for maintenance staff.

Community use and maintenance

Issues around community use of Wyatt Park and associated grounds maintenance include litter collection and perceptions of safety.

Litter collection following larger events, such as sporting carnivals and festivals, requires close to one full day of maintenance by the grounds staff. Current expectations regarding litter collection are not suitable. This task could become the responsibility of the organisations for their facilities. This could be supported by Council through integration into hire/lease agreements.

The percieved safety of public users after hours or at night time is also a key issue. While after hours security is present at Wyatt Park, there is evidence of anti-social behaviour taking place in areas within the park (e.g. vandalism and drug paraphernalia at the skate bowl).

If there are plans for a greater level of park use and additional amenities, there will need to be consideration of how this will impact on the maintenance program (additional staff would be required).

A summary of feedback from the interview is organised by theme in the table below.

- » Building condition reporting and scheduled repair/maintenance works will be integrated into the future Strategic Management Plan for Wyatt Park (NOTE: The POM will not incorporate building condition issues, but will make recommendations for future leases/licences to address this issue and for implementation by Council's Property and Facilities department).
- » The various leasing, licensing and associated maintenance agreements in place at the park received good feedback from the majority of organisations
- » Plans for increased use of Wyatt Park should take into consideration the additional time and resources required for grounds maintenance
- The future use of Wyatt Park needs to consider the open space network in Cumberland Council and also the recreation and open space needs of a future population projected to reside in a high density urban environment
- The financial sustainability of organisations at the park should be considered in conjunction with the suitability and accessibility of services offered, including whether they meet community needs socially and economically

4 Outcomes of consultation with park organisations

This chapter provides a summary of the outcomes of the consultation with key organisations using Wyatt Park (as identified in chapter 2, section 2.2).

Each interview investigated the organisation's:

- » Previous and current use of facilities and spaces in Wyatt Park
- » Feedback on the suitability of Wyatt Park spaces and facilities, for their organisation and wider community use.

Representatives were also asked to suggest changes to the function and/or design of Wyatt Park, so it would better accommodate future organisational and wider community use. The prompts included:

- » What are your organisation's plans for the future (expansion of existing programs, new programs, plans for membership etc.)?
- » What is your vision for your organisation at Wyatt Park in the future?
- » What changes to Wyatt Park are required to achieve your organisation's vision?
- » What ideas do you have for attracting larger numbers of people and users to the park/park facilities?
- » Do you have any ideas for changes/improvements to the park so the park could better meet the needs of the broader community?

The following sections provide a summary of the findings from the interviews by park space/facility. For spaces/facilities with more than one organisation involved, the interview responses have been collated.

Key to feedback tables included in the following sections

- ✓ Working well
- X Not working well

4.1 Auburn Athletics Track

The Auburn Athletics Track is located at the northern edge of Wyatt Park, bordered by Olympic Drive and Percy Street.

The facility is utilised by a senior and junior athletics club, Asics Wests Athletics Club (Asics Wests) and Tiger Wests Little Athletics (Tiger Wests), who operate on a co-lease agreement. The facility is also used by schools for school carnivals.

The clubs have been responsible for the funding and construction of most built structures at the facility and are the owners of the athletics equipment used in training and competitions.

Arrangement for use

Both clubs have access to the field, buildings, facilities and equipment surrounding and within the facility, excluding the kiosk which is not used by Tiger Wests. The facility is fenced and locked when not in use by the clubs or for school carnivals.

Asics Wests is the main point of contact with Council regarding lease arrangements and maintenance of the facility.

Services and programs

Asics Wests' and Tiger Wests' services and programs are organised and managed by volunteers. Both clubs offer training, two-three nights per week and Friday evening competitions.

Asics Wests is also responsible for managing school carnival and community group bookings at the Track and providing the necessary equipment. Currently, the track and its facilities accommodate approximately 20 booked events (including school carnivals) per term.

Members

The dispersal and quantity of registered members differed significantly between the two clubs.

At the time of the interview, Asics Wests recorded approximately 50 regular members at training sessions, while Tiger Wests have registered 160 members in 2017.

While both clubs indicated that most members chose to drive to the park, Asics Wests provided that only 15-20% were travelling from within Cumberland LGA. Tiger Wests had a significant local membership base, with 90% recorded as living with the LGA boundaries.

In discussions around the lower numbers and larger dispersal of members, Asics Wests suggested that:

- » Increased diversity in sports offered to high school aged children was leading members away from athletics into club-based competitive sports
- » Specialisation in specific athletics events has led to members choosing to attend clubs which offer higher skilled training in that event.

Feedback on Auburn Athletics Track

4.2 Lidcombe Oval, Velodrome and facilities

Lidcombe Oval is located within the centre of Wyatt Park, adjacent to the Auburn PCYC at the end of Church Street. The space is used for training and competitions by three sporting organisations:

- » Lidcombe Auburn Cycling Club (LACC)
- » Kids on Bikes (KoB)
- » Auburn Warriors Rugby League Club (Warriors)

At the time of this report, a representative from the Warriors was unwilling to participate in the interview. Where possible, information provided by LACC and KoB regarding the Warriors' use of Lidcombe Oval and facilities has been included.

Arrangements for use

Lidcombe Oval incorporates a variety of spaces, which are co-shared by LACC, KoB and the Warriors. The spaces and how they are used are summarised below:

- » The field is used by the Warriors for weeknight training and Friday night/weekend competitions
- » The velodrome, surrounding the field, is used by LACC and KoB four to five nights a week for training, and competitions on Friday nights (Summer only) and Sunday afternoons
- » The storage shed/toilet block at the northern end of the field is used by KoB and the Warriors
- » The grandstand is used as seating and as a spectator viewing area by all organisations
- » The changerooms and storage in the grandstand act as joint changeroom for LACC and the Warriors, as well as storage space for LACC

An area of congested use in this space is the field and velodrome, with the velodrome circling the field. For the safety of their members, LACC and KoB do not use the velodrome when the Warriors have training or competitions as stray balls and players can cause hazards on the track. Entering and exiting through the western gate can also become congested. Bookings for the field or velodrome are made through a week-to-week booking arrangement with Council.

Services and programs

LACC has been operating for 100 years and have an established identity at Wyatt Park in the competitive cycling community. They are a competitive cycling club, and one of the few to host and promote local and metropolitan track racing.

KoB has been operating at Wyatt Park for three years and provides three programs. All programs focus on increasing participation and skills in cycling for young people aged 5 to 19 years.

Members

Within its time of operating, KoB has reached approximately 60-70 members, most of which are local to the Cumberland LGA. In contrast, LACC provided a membership base of 500 members, which contained a mixture of persons from within and beyond the Cumberland LGA.

Both organisations reported that the majority of their members access Wyatt Park by car.

4.3 Marie Dunn Netball Courts

The Marie Dunn Netball Courts (including associated facilities) are positioned between the Auburn Athletics Track to the north, Auburn Basketball Centre to the east and Auburn PCYC to the west. Along the western edge, the courts are bordered by Percy Street.

Arrangements for use

There are 17 courts in the space which are currently used by the Parramatta Auburn Netball Association (PANA) and Netball4All.

At the time of writing this report, PANA's license renewal with Council had been disrupted due to the recent amalgamation.

Netball4All pay court hire to PANA for their social competitions and do not have a formalised sharing agreement.

Services and programs

PANA facilitates competitive netball competition and training, starting from children aged 5 years. The club season runs throughout Winter and the courts are utilised weeknights for training and all of Saturday for competition.

Netball4All have access to the facility on Monday and Thursday nights for social competitions and use of the Clubhouse for organisation. The social competition runs throughout the year.

Members

PANA has approximately 500 members and operates competitions on almost half of the available courts. In discussions around the reduction in their member numbers explanations for membership decline included:

- » The defection of larger clubs previously in the PANA organisation to surrounding competitions in Blacktown and Bankstown
- » Promotions and organisation by volunteers and constraints on people's time
- » The increasing variety of competitive weekend sports available to girls
- » Very small percentage of club members come from outside the area

Netball4All have a mixture of male and female players, ranging in membership from 600-800. The organisation was unsure of approximately how many members participated from beyond Cumberland LGA, but did provide that their members 'lived all over Sydney'.

Feedback on Marie Dunn Netball Courts

The following table summarises what works well, isn't working well and the organisations' ideas for the future. It combines information recorded in a phone interview with a PANA representative and a written response to interview questions provided by Netball4All.

4.4 Auburn Basketball Centre

Auburn Basketball Centre is located along Olympic Drive, with vehicle access at the north-eastern edge of Wyatt Park. Parking is available adjacent to the centre within Wyatt Park.

Arrangements of use

The Auburn Basketball Centre facility is occupied by the Parramatta Basketball Association (the Association). Council remain the owners of the centre, while the Association lease the centre from Council and have funded the internal fit out of the building and ongoing building maintenance.

Services and programs

The Association use the centre for the full week. This includes organising and managing competitions five nights a week, Saturday court hire and internal competitions, as well as social hire for corporate and other events throughout the week. Competitions are community focused as the Association is not part of Basketball NSW.

The Association also provides office space to Kids on Bikes organisers within the centre.

Members

The centre contains three courts which are operating at capacity. At the time of writing this report, the Association had approximately 1,500 regularly competition playing members, in addition to hirers for social games.

During the discussion, the Association indicated that they had plans to extend the centre to four courts (through a partnership agreement with Council). It is expected that this would increase competition memberships to 2,000.

Feedback on Auburn Basketball Centre

4.5 Ruth Everuss Aquatic Centre

The Ruth Everuss Aquatic Centre is a new facility at Wyatt Park. Opening in April 2017, the centre is located at the junction of Olympic Drive and Church Street, at the southern-most end of Wyatt Park.

Arrangements of use

The centre is operated by Belgravia Leisure through a formal arrangement with Council.

Council funded and contracted the construction of the centre before putting the management out to tender. Belgravia Leisure have been contracted to manage and operate the service for a possible three or five year arrangement, before the centre will be put back out to tender.

The arrangement is bound to National and State aquatic centre safety standards, which can void the lease if not met.

Services and programs

The centre contains a variety of spaces, including:

- » Outdoor 'splash' play space (play equipment and water sprouts, etc.)
- » Gym and fitness room
- » Separate internal wading pool
- » Indoor lap pool
- » Outdoor lap pool and stands
- » Outdoor water polo pool
- » Office spaces and rooms for hire.

In the time following its opening it has provided school competitions, swim programs, water polo, gym membership and fitness groups as well as room hire for functions.

Members

The majority of members of the new facility are from within the Cumberland LGA. Following the initiation of swim school programs, the membership rates have reached 580 with an additional 50 persons taking up membership for the gym facilities.

At capacity, the centre could hold up to 4,000 members in the swimming programs and 500 members for the gym facilities.

Feedback on Ruth Everuss Aquatic Centre and facilities

Auburn PCYC facility 4.6

The Auburn PCYC is accessible from both Percy and Church Streets and is located adjacent to the Marie Dunn Netball Courts, on the western edge of Wyatt Park.

Arrangements for use

The Auburn PCYC was approached by Council to redevelop and manage the building (previously used as Netball Australia Headquarters). Funding to retrofit the building for the PCYC was awarded through a grants system and the PCYC now lease the facility from Council. The facility remains in the ownership of Council, however arrangements around maintenance remain ambiguous between Council and PCYC.

Services and programs

Auburn PCYC offers programs and services from 18 months of age and up, but their focus is on services for young people 24 years and under. The organisation also hires out their sports facilities and rooms for causal use. The facility includes a hall for indoor sports and numerous rooms of various sizes for hire and for use by young people.

Members

Since opening in 2016, the membership numbers for the Auburn PCYC have reached 4,200, which represents 40-50% capacity. In addition to Auburn-based members, members from other PCYC facilities also use the Auburn PCYC.

Most members drive to the facility. Younger members, mostly high school aged, also travel to by train to their closest station then walk, and are picked up by car when leaving.

4.7 Auburn Youth Centre facility

The Auburn Youth Centre is located along Church Street, adjacent to the Ruth Everuss Aquatic Centre. It is positioned in front of Wyatt Park Fields and next to Lidcombe Oval (and velodrome), to the north.

Agreements for use

There are two community organisations operating out of the Auburn Youth Centre facility. Auburn Youth Centre is the primary lease holder with Council and Woodville Alliance is a subtenant.

Auburn Youth Centre as an organisation receives funding from the Department of Family and Community Services and received a grant to retrofit the facility for use. Additionally, Woodville Alliance approached Auburn Youth Centre requesting use of space and has since carried out kitchen upgrade works and upgrade works to the office spaces used by the organisation.

Maintenance and additional work agreements for the building are influenced by the heritage controls in place.

Services and programs

Auburn Youth Centre provide support for persons from 12 to 24 years. The organisation provides events and activities around youth development and skills, and also acts as a referral service.

Woodville Alliance offers a diverse range of services, including family mental health awareness and support, early intervention programs for 0 to 18 year olds at risk of and/or suffering from a mental illness.

Spaces within the facility include:

- » Sectioned meeting/study rooms
- » A media room with technology
- » Hall with timber floors suitable for indoor sports and recreational activities.

Members:

It is difficult to measure membership or use rates for both Auburn Youth Centre and Woodville Alliance. This is due to the operating mechanism of each organisation, including:

- » An informal system utilised by Auburn Youth Centre, which does not record the frequency of member visits or if members visit more than once
- » A case worker load used by Woodville Alliance which calculates capacity by alternate measures.

At the time of writing this report, the facility was not operating at capacity.

Feedback on Auburn Youth Centre facility

The following table combines what works well, isn't working well and the ideas for the future of Auburn Youth Centre, from a combined interview with Auburn Youth Centre and Woodville Alliance representatives.

4.8 Wyatt Park Fields

The Wyatt Park Fields are located behind the Auburn Youth Centre and next to Lidcombe Oval (and Velodrome). Although the fields can be seen from Church Street, entrance from the street is not direct and difficult to find.

Agreements for use

At the time of writing this report, no organisation was established at Wyatt Park Fields. The fields are now used for hosting large events. The two major user organisations include:

- » Organisers of Africultures a festival held annually and hosts close to 20,000 people
- » Islamic Community Centre hosting religious events associated with Ramadan.

In these instances, the space is booked through Council who assists with traffic management and organisation of the event.

Organisations based at Auburn Youth Centre also reported to have occasionally booked the fields for sport and recreational activities, and the space has been a focus of a community safety audit report undertaken by the Flemington Local Area Command (FLAC).

Services and programs

Wyatt Park Fields is used as a location for holding larger community and cultural events approximately 5 times a year.

Membership

Membership is not applicable to Wyatt Park Fields.

Feedback on Wyatt Park Fields

Representatives from Africultures, the Islamic Community Centre and the FLAC police members were interviewed when investigating what did and do not work well at Wyatt Park Fields, and ideas for its future use. Their responses have been organised by theme in the following table.

4.9 Auburn-Lidcombe Girl Guides Hall and Lidcombe Scout Hall

Auburn-Lidcombe Girl Guides Hall (Guide Hall) and Lidcombe Scout Hall (Scout Hall) are located in close proximity, adjacent to Olympic Drive. The Halls are situated on an area of land on the eastern edge of the canal, disconnecting the halls from the rest of Wyatt Park (and other facilities at the park).

Agreements for use

The Auburn-Lidcombe Girl Guide branch is accommodated in the Guide Hall, which is owned by Girl Guides Australia. Although the Scout Hall no longer functions as a scout branch, it remains in the ownership of Scouts Australia and is managed by a Scout leader.

Maintenance of the Guide Hall is funded by the branch and conducted by volunteers, usually parents of members. Alternatively, maintenance for the Scout Hall is organised by the Scout leader.

Neither organisation was clear of ownership of the land occupied by their respective halls.

Services and programs

The Guide Hall provides a space for weekly evening guide meetings and additional events for the Girl Guide members.

The Scout Hall had not been used for Scout meetings for 25 years and is now hired out on a weekly basis. It is most popular on weekends, being used by church groups and sometimes for private birthday parties.

Members

The Guide Hall members range are girls ranging in age from 10 to 20 years. The organisation is not operating at capacity. The Scout Hall has not accommodated Scouts members for 25 years.

Feedback on Auburn-Lidcombe Girl Guides Hall and Lidcombe Scout Hall

Representatives from Auburn-Lidcombe Girl Guides and the Scouts Australia were interviewed when investigating what did and do not work well at their respective halls. The representatives also

suggested ideas for future use of their facilities. Their responses have been organised by theme in the following table.

4.11 Summary of key findings from consultation with park organisations

- » All organisations at Wyatt Park were supportive of increased community use of the park, including greater use of their own facilities and for the wider park
- » Organisations not satisfied with their current leasing agreements referenced the recent amalgamation as the main disruption to their lease renewal or modification
- » All organisations were eager to improve communication, co-ordination and co-share arrangements across the park many requested the reinstatement of the Wyatt Park Committee
- » Several organisations suggested willingness towards or support for a shared clubhouse that could be accessed by all the key organisations at the park
- » Poor signage, wayfinding and no street numbers were repeatedly identified as 'not working well' by organisations when discussing their individual facilities and Wyatt Park overall
- » Poor lighting around and poor/unappealing paths into the park were repeatedly raised as a barrier to greater community use of the park
- » The deteriorating aesthetic and condition of buildings at the park was consistently identified as a necessary improvement for greater community use to occur
- » Parking is generally good/adequate but issues can arise during peak times, or when several venues are operating activities or events, which could require improved management systems
- » Increasing the visibility of activities happening at the park was suggested as a possible solution to increase both safety and security, and promote awareness of the park in the Cumberland community
- » Most co-lease or sub-lease arrangements between organisations received good feedback, the exception being Lidcombe Oval and Velodrome, with organisation expressing ongoing issues with booking and Council management
- » Toilets, member amenities (changerooms), storage, seating and shade were consistently suggested by organisations as improvements to their facility or space at the park
- » The future vision for Wyatt Park was predominantly expressed as 'remaining as a sporting hub' or sporting destination
- The future visions for Wyatt Park also considered wider community use, and suggested increasing the public amenities across the entire park, such as seating and shade, bubblers and taps, play equipment, walking/cycling tracks and BBQ facilities.

5 Community consultation outcomes

This chapter provides a summary of findings from the community survey. The survey provided significant feedback and input from community organisations, groups and individuals.

In conjunction with the survey, Council also prompted the Cumberland community to leave a comment or experience of Wyatt Park on Council's Facebook page. These comments are summarised at the end of this chapter, following the summation of the community survey.

5.1 Who responded to the survey?

A total of 144 people responded to the survey.

Of the people responding to a question about existing use of the park, 81 described themselves as existing users and 6 as non-users.

When reading the survey findings, it is important to consider the profile of participants. It is noted that the survey sample was characterised by a:

- » considerable proportion of people who live outside the LGA
- » higher proportion of women to men
- » low participation by people from culturally and linguistically diverse backgrounds.

There was also a high response rate from existing park users and people using the park to provide, participate in or watch sports (in particular netball).

While the survey has provided valuable insights and a range of perspectives, they cannot be considered representative of the broader Cumberland community.

(NOTE: not all respondents answered every question of the survey therefore numbers of responses to each question varied).

Profile of respondents

The following provides a summary of key characteristics of respondents (who answered questions about their profile):

- » The majority of respondents were female (female=67, male=30)
- The highest number of respondents were aged 35-49 years (45 responses). The next highest representation were people aged 25-34 years (21), followed by 50-59 years. No respondents were aged 70 years and over and only two respondents were aged 17 years or younger
- » There was almost an even split between respondents with school-aged children (46) and those without school-aged children (49)
- » There were very low number of respondents who mainly speak a language other than English at home (English=92, other language=4)
- » A slightly higher number of respondents lived in other local government areas (51) than in the Cumberland LGA (45).


Interest in Wyatt Park

Of the respondents who answered a question about their interest in Wyatt Park (83 responses), the selections included:

- » the majority reporting to be a participant in a sporting organisation or group (63 responses)
- » residents or individual community members (31)
- » representatives of a sporting organisation or group (22)
- » representatives of a community or cultural organisation (14).

5.1.1 How do respondents access and use the park?

Time and frequency of park use

The most common time respondents reported to use the park is weekday evenings, followed by weekend mornings.

The majority of respondents reported to use the park once a week or more (73 of 78).

Travelling to the park

Travel to the park by car formed the majority of responses (70 of 78). Walking was the next most common means of accessing the park (11).

Types of use


There were 78 responses regarding the types of use of Wyatt Park by respondents. The responses included:

- » a majority playing/participating in organised sport at Wyatt Park (63)
- » watching sporting games or competitions (27)
- » providing sports programs (18)
- » walking/jogging/personal fitness (14)
- » playing informal sports or games (14).

Sports played/provided/watched

The most common sport respondents reported to play, provide or watch at the park was netball (48 responses), followed by cycling (11), athletics (4), soccer (3), swimming (3), basketball (2), gymnastics (2) and Oz tag (1).


Facilities and spaces used

The most common facility respondents recorded to use in the last 12 months was the Marie Dunn Netball Courts (45 respondents). This is in line with the high number of respondents who reported to play netball. The next most common facilities/spaces used by respondents were:

- » Auburn Ruth Everuss Aquatic Centre (14 respondents)
- » Auburn PCYC (13)
- » Lidcombe Oval velodrome (12)
- » Wyatt Park field (12).

5.1.2 Reasons why respondents do not use the park

The reasons respondents selected for not using the park included:

- » 'The park has an unappealing look and feel' (3 responses)
- » 'The park or facilities are in poor condition' (3)
- » 'The park/facilities are difficult to get to' (2)
- » 'I use another park/facility elsewhere' (2)
- » 'None of my friends/community go there' (1)
- » 'Activities, programs, events offered at the park or park facilities do not meet my needs or interest me' (1)
- » 'I do not feel safe travelling to the park/within the park' (1).

5.1.3 Feedback on the park

Experience of getting to the park

Of the respondents (66) who answered a question about experiencing difficulties in getting to the park, the majority reported that they did not experience any difficulties (45). 21 respondents reported that they have experienced difficulties getting to the park.

Key difficulties experienced included:

- » Limited/poor parking (particularly on Percy Street and for users of the netball courts)
- » Visibility and safety issues relating to poor lighting
- » Poor quality paths and surfacing and a lack of footpaths in some areas
- » Traffic and access issues.

Feedback on park facilities and spaces


Respondents were asked, of the facilities they use at the park, how well have they met their needs. They were provided with four response options:

- » it met my needs very well
- » it met my needs quite well
- » it met my needs not well at all
- » I don't know/I didn't use this facility

In all spaces/facilities the predominate response was the final option, no use/awareness of the space/facility. The one exception to this was the Marie Dunn Netball Courts, which is likely to align with the high number of respondents identifying netball as their main activity at Wyatt Park.

Awareness of heritage values

The majority of respondents (54 of 66) were unaware of the heritage values in the park. Facilities/aspects that respondents understood to be of significance (heritage value or locally, culturally significant) included:

- » Lidcombe Oval and grandstand
- » Velodrome at Lidcombe Oval (one of the oldest and one of only five velodromes in Sydney)
- » Auburn Ruth Everuss Aquatic Centre
- » Marie Dunn Netball Courts (significant for past and future netball players
- » Auburn Athletics Track (as a field specifically assigned to athletics)
- » Auburn Youth Centre.

One respondent also noted the important role the park has played over many years as a valuable open space for the community. Another respondent commented that the park's history "should be preserved and honoured".

5.1.4 Ideas for the future


The role of the park in the future

The majority of respondents believed the park should continue to play the role of 'a sports hub' in the future (87 responses), which likely reflects the high proportion of sports participants/providers/ spectators responding to the survey.

The next most popular response was 'a place for informal and family recreation' (62) and 'a youth precinct' (56), suggesting respondents are interested in the park providing offerings beyond sports in the future.

A full breakdown of responses is provided in the following graph. (NOTE: respondents could select more than one response to this question).

Future activities at the park

The majority of respondents reported to be most interested in providing, playing or watching organised sport or participating in formal recreational programs at the park in the future (130 responses). This reflects the high proportion of respondents who currently provide, play or watch sports at the park.

The next most popular activity nominated was informal outdoor sports or games (28), walk, jog or personal fitness (26), use specialised recreation equipment e.g. skate, scooter, BMX or outdoor fitness equipment (24) and ride a bike/learn to ride a bike (21).



Future sports at the park

The responses a question about the types of sports participants would like to see provided at the park in the future predominantly reflected the sports currently provided, indicating they would like to see these sports continue to be provided in the future.

The most common response was netball (37 responses), reflecting the high representation of existing netball players currently using the park responding to the survey.

Other popular sports nominated included:

- » Basketball (16)
- » Volleyball (2)
- » Cycling/bike riding (15)
- » Soccer (6)
- » Athletics (10)
- » Swimming (4) and Swimming for females (1)
- » Skateboarding (4)
- » Rugby league (4).

Other sports mentioned that received 1-3 responses included:

- » Triathlon, duathlon or aquathon
- » Table tennis
- » Tennis
- » Badminton
- » Football
- » Dance
- » BMX, mountain biking
- » Scootering
- » Gymnastics
- » School sports.

Future park inclusions

The survey included a question about what facilities and amenities should be included in the park in the future. Reoccurring responses included:

- » Public toilets
- » General amenities including bubblers, bins, shade/shelter and seating
- » Additional carparks/parking spaces and improved surfacing
- » A walking/cycling path around the park
- » Improved amenities at facilities (clubrooms, toilets and changerooms)
- » Café/food outlet/s
- » Play equipment
- » Outdoor gym equipment*.

*One respondent did not believe outdoor gym equipment should be provided as "the fitness industry is saturated" and outdoor gyms are not well used

5.2 Summary of Facebook comments

Council promoted further community consultation through their Facebook page. The comment was posted on 13 June 2017 by Council, and included:



Cumberland Council is conducting a survey on the use of Wyatt Park, Lidcombe. We are keen to hear from individuals, organisations and groups who currently use the park as well as those who are interested in using it in the future. Have your say by visiting <u>https://tinyurl.com/ycekyowo</u>

All the information you provide will be treated as confidential. Surveys close on Friday 23 June.

Overall the post received 2 comments, one proposed the future use/role of the park, and the other addressing parking to access the park and Lidcombe station. Both comments are provided below:

- » 'Be great to see it converted into a Big Nature Park Reserve in our own council area like Nurragingy Reserve for Weddings and Picnics or events such as Christmas Shows. Or better still bring back to Lidcombe Oval the footy with the mighty Maggies (Western Suburbs Magpies Rugby League)'
- » 'Build a multi-story car park where the southern car park (outside Ruth Everuss Aquatic Centre) is with a walkway over Olympic Drive for commuter parking (to access Lidcombe train station) or extend the car park along between Olympic Drive and the creek [and] remove the 4 hours parking limit

5.3 Summary of key findings from consultation with the broader community

When considering the survey findings, it is important to note that the survey sample was characterised by specific groups (women, adults aged 25-49 years, English speakers and people predominantly using the park to provide, participate or watch sports). While the survey has provided valuable insights and a range of perspectives, they cannot be considered representative of the broader Cumberland community.

Key findings

Key strengths of the park identified by the broader community included:

- » The specialist sports and recreation facilities provided
- The mix and range of facilities and spaces (catering to a diverse range of sports and activities) and the opportunities and choice these facilities provide to the community
- » The green space/parkland that the park provides (particularly in an area experiencing densification)
- The potential of the park to be a local community gathering space and place for greater informal recreation in the future.

Key improvements and additions required to be made to the park that were identified in the community survey included:

- » Improving access to the park (most notable through the upgrade of footpaths leading to and within the park)
- » Greater community awareness of the variety of activities/events occurring in the park
- » Upgrading/updating old and dated facility buildings
- » Upgrading amenities at facilities (including toilets, changerooms, canteens and storage)
- » Providing publicly accessible toilets outside facilities as well as providing bubblers and bins throughout the park
- » Providing shade and shelter at facilities and around the park
- » Improving carparks (surfacing, line marking, lighting) and the provision of additional carparks/spaces
- » Providing a continuous pedestrian and cycle path around the park and fitness stations for personal fitness and recreation
- Creating family friendly spaces (including playgrounds, picnic and BBQ facilities/areas, scooter and skate park)
- » Improving lighting across the park to improve safety
- » Improving signage and wayfinding and promotion the park and park offerings (by Council and organisations).

The future role of the park was predominately expressed as continuing to play the role of 'a sports hub' in the future. While this may be reflective of their current use and interest in the park, it does highlight the important role the park currently plays to as a higher order district or regional active open space.

A significant portion of respondents also recognised the potential for this significant open space area to better meet the needs of the Cumberland community as 'a place for informal and family recreation' and as a youth precinct in the future.



BACKGROUND TO THE MASTERPLAN FOR WYATT PARK

INTRODUCTION

Where is Wyatt Park?

Wyatt Park is located on Church Street, Lidcombe approximately halfway between Lidcombe and Auburn stations

The park adjoins Olympic Drive, a major urban link road, and the Main Western Rail Line connecting Sydney to Penrith, Richmond and the Blue Mountains.

Being about 23 hectares in size, Wyatt Park is an important park in Lidcombe. It has a long and ongoing history as one of the area's most important sports grounds

Why do we need a Masterplan?

Cumberland Council is concerned about the condition of many facilities in Wyatt Park and the declining condition of the park overall.

As a first step in improving the park, Council resolved to prepare a Plan of Management and Landscape Masterplan.

Together they will describe how Wyatt Park will be used and developed over the next five to ten years, to improve the quality of recreation facilities and make Wyatt Park a more appealing place for recreation.

SUMMARY OF OPPORTUNITIES FOR WYATT PARK

What you told us: Wyatt Park is a valued place

In June 2017, Council consulted with existing users and the wider Cumberland community to understand their issues and experiences of the park

We learned that Wyatt Park is highly valued for a number of reasons including

- · The park is an important sporting precinct
- · The park is large and has a range of sporting facilities
- Some of the sporting facilities are unique and/ or of high quality
- The park has a long tradition and important heritage values as well as social and cultural associations
- Wyatt Park is a 'green oasis' and has important environmental values.

Wyatt Park has the potential to offer more

It is considered vital that Wyatt Park continues It is considered vital that Wyatt Park continues to provide a major venue for active sports activities. At the same time, the park has significant potential to provide additional recreation opportunities to meet the need for general, social and family recreation such as walking, picnicking or children's play.

Parks are important for the growing

The population of the Cumberland Local Government Area is expected to grow by more than 30% over the next 20 years, with even greater growth in Lidcombe and Auburn. This growth will lead to increased apartments and high density living. As people have less private open space. Wyatt Park and other parks will become more important for general, passive and family recreation.

We see an opportunity that large undeveloped areas in Wyatt Park could be transformed to better meet this need.

We want to make it easier and safer to get to and around Wyatt Park

Wyatt Park is close to major town centres and roads but it can be hard to get to and find your way around. Parts of the park are difficult to access and don't feel safe. It is particularly difficult to access and move within the park for pedestrians and cyclists.

We see an opportunity to make it easier for people to get to and around the park. This would especially benefit young people so that they can enjoy the place and take advantage of facilities including the Youth Centre

We want to make it easier to enjoy Wyatt Park

Wyatt Park has many great sporting facilities but it lacks basic recreation infrastructure including paths, lighting, seating, play equipment or picnic areas. Many parts of the park don't have shade which makes them uncomfortable to be in, especially in summer

We believe Wyatt Park can be made a great place to be enjoyed by everyone, all year round

We want to make Wyatt Park more inviting

A number of buildings in Wyatt Park are old or run down and do not look inviting.

We believe that Wyatt Park has the potential to look and feel more inviting and friendly, and to be a family-friendly and safe place to be for people of all ages, at all times of the day and night.

Letting the community know about Wvatt Park

Many people in Cumberland don't know about Wyatt Park, especially those people who don't participate in sports activities

The exhibition of masterplan options is a key step in Council working towards raising awareness of the park, and working with the Cumberland community to decide what the park should look like, and how it should function in the future

Best practice

We have reviewed current best practice for planning parks. We found the best parks are characterised by:

- Flexibility allowing different uses at different times
- Adaptability accommodating new or different uses as needs evolve

- Co-location bringing facilities and services together in one place
- · Community development through events and activities
- Multi-use shared use of facilities
- Compatibility appropriate to the site and cognizant of what is available elsewhere







A PoM is a document that describes how community land will be managed by Council. The PoM will include a description of how Wyatt Park will be used, improved and managed in the future. The PoM will also inform Council's planning, budgeting for capital works and ongoing management and maintenance services.

Council anticipates that the Draft PoM for Wyatt Park will be placed on public exhibition in November 2017

Council will notify the community and exhibit the Draft PoM and preferred masterplan for 28 days. There will be a number of opportunities for the community to have their say during this period.

Council expects the final PoM and preferred masterplan will guide decision-making around the park for at least the next five to ten years. The PoM and masterplan will be periodically reviewed to ensure they remain current, relevant to the community's needs and consistent with Council's strategic and community planning.
