- b) Council develop a schedule of upgrades across the local government area with promotion of females facilities;
- In developing a future improvement programme, Council adopt a targeted position for inclusion of female facilities in at least 50% of sporting sites by 2030;
- d) The financial implications be included in the report and its implications be included in Council's Long Term Financial Plan;
- e) Council pursue opportunities for financial assistance from both state and federal sources as a matter of urgency;
- f) The report also include what immediate actions can be undertaken to accommodate the deficiencies of female facilities at existing sporting grounds; and
- g) All sporting groups within the Cumberland local government area be informed accordingly and that they be engaged in a consultation process as part of the planning phase.
