 - Utilise existing internal resources and systems (e.g. mapping, asset management tools, service request logs) to identify and track these breakouts.
- 2. Provide a breakdown of outstanding restoration sites by suburb, including the type of restoration required and the responsible utility provider.
- 3. Confirm the utility service provider responsible for each breakout and ensure they are held accountable for permanent restoration costs. Where possible, initiate cost recovery for restorations undertaken by Council on their behalf.
- 4. Prepare and implement a Council-managed plan to ensure:
 - All future utility breakouts have a clearly monitored timeline for permanent restoration.
 - Inspections are conducted at the completion of work to confirm compliance.
 - Utility providers are formally notified of their obligations, and penalties considered for non-compliance.
- 5. Provide Councillors with regular progress updates on:
 - The audit outcomes.



- Restoration completion dates; and
- 6. Identify any costs associated with actions detailed above, with potential funding sources outlined.
